Dinner Speech by Susan Fraser

We were hoping that Grace Edwards could join us today for both she and Edna put in many years working for the PAA and organizing our specialty shows long before we had computers and email. The poodle cloth draped along the wall in the judging ring is the original trophy table cloth made by Edna Joel. I hope that you have noticed the posters on the walls with pictures and membership lists from these early years. Your catalogue/yearbook has pictures that will bring back pleasant memories. Can you identify these pictures? In the next few newsletters we shall attempt to identify them.

Our first specialty was held in Casa Loma with Ann Rogers doing her first judging assignment, Best in Show was Hans and Andrena Brunotte's Am Can CH Poodhall Gus. The BIS trophy donated by de la Fontaine poodles, a punch bowl set, has been redonated as the Gus perpetual trophy. The Best in Show trophy today offered by Rosemary Hagen was also a punch bowl set.
