- To keep my dogs under conditions as described in "[A Code of Paractice for Canadian Kennel Operations](#)" written by the Canadian Veterinary Association.
- To accept with dignity the cancellation of my membership should my actions contradict the aforesaid.
- Executive Members and Directors of the Club shall refrain from using their Board position on any correspondence, advertising, emails or web pages (either personal or professional) other than that pertaining to official Club business.

# MEMBER TO MEMBER

## Vaccination Notes by Susan Fraser

While at PCA, I attended Dr. Ron Schultz's lecture on vaccinations, what you should do, what you shouldn't, and what you should and shouldn't know. He had a lot of hand-outs which I took, and I made a few notes. I thought I would share that information with you since some of you expressed interest in the subject matter. Some of it you will find you already know, but some of it was news, especially his thoughts on vaccinating for canine influenza, which I will get to shortly.

There are certain core vaccines and certain non-core vaccines. The core vaccines are canine parvo, distemper, canine adenovirus-2 (CAV-2), & rabies. The first three are absolutely & always required. The fourth is required by law in all fifty states in three year intervals. Some counties and local jurisdictions have more restrictive requirements but all fifty states do permit three-year intervals. They are trying to prove that seven year intervals are adequate but haven't gotten there yet. CAV-1 is NOT recommended due to a significant risk of hepatitis blue-eye reactions, and CAV-2 cross protects for CAV-1. He recommends that puppies should be given three doses, NOT four, at intervals of 3 to 4 weeks, ending with 16 weeks, with a one year booster vaccination given one year after completion of the initial puppy series.

He recommends that you wait until a puppy is 8 to 10 weeks old before starting puppies on vaccinations because they have certain immunities from their mother's milk until that time and only give three sets of shots, not four. Six weeks of age is the WORST time to start puppies on shots.

The non-core vaccines are: parainfluenza, bordatella, lyme, leptospirosis, CCV (canine coronavirus), giardia, rattlesnake, and periodontal disease.

He put up a Powerpoint presentation on the estimated minimum duration of immunity and the estimated relative efficacy percentage of each type of vaccination, which I copied down. I will list them below:

Estimated Minimum DOI

Estimated Relative Efficacy Percentage

Canine Distemper (Modified live) Greater than or equal to 7 yrs.  
Greater than or equal to 99%

Canine Distemper (Recombinant) Greater than or equal to 5 yrs.  
Greater than or equal to 99%

Canine Parvo (Modified live) Greater than or equal to 7  
yrs. Greater than or  
equal to 99%

Canine Adenovirus (modified live) Greater than or equal to 7 yrs.  
Greater than or equal to 99%

He also stated that it is unnecessary to titer more frequently than every three years because you're just wasting your money. You should only titer for parvo, distemper & rabies for shipping purposes & not adenovirus because they are automatically immune from adenovirus once they've been vaccinated. Canine infectious hepatitis has been eradicated.

Interesting note: he believes it stupid, and he came out & said so, for vets to vaccinate for leptospirosis and not vaccinate for canine influenza, which has much more serious consequences. We rarely see leptospirosis any more, but we do see canine influenza, and it is immediately contagious - if exposed, all dogs will immediately get it. They have no natural immunities. It can be fatal and does have serious consequences. He said they should be vaccinating for canine influenza but not necessarily for leptospirosis unless they've seen an outbreak in their region.
